#### ESTABLISHMENT OF SPECIAL CELLS

- The Constitution of the country, promulgated in 1950, recognizes the scheduled castes and the scheduled tribes as the two most backward groups needing special protection. A number of provisions have been made in the Constitution with a view to abolish all forms of discrimination and put these groups at par with others.
- According to the 1998 UGC Guidelines for the establishment of Special Cell for Scheduled Castes and Scheduled Tribes, for the Universities and deemed Universities, the purpose of these Cells is to monitor the admission of students and the recruitment of teaching and non-teaching staffs at various levels
- University has constituted a committee to look into the discriminating complaints received from the SC's/ST's/OBC's Students/Teachers/Non-Teaching Staff.

- **POST MATRIC SCHOLARSHIPS** -The objective of the scheme is to provide financial assistance to the Scheduled Caste, Tribe and Other Backward Classes students studying at post matriculation or post-secondary stage to enable them to complete their education.
- GOVERNMENT OF MAHARASHTRA FREESHIP SCHEME- The Tuition and Exam Fee is granted to the students belonging to backward class pursuing their course/programme from a recognized educational institution, without taking into consideration the income of parents/guardians. This schemeis applicable for the SC/ST/NT/SBC/OBC category.
- NATIONAL SCHOLARSHIP FOR PERSONS WITH DISABILITIES (2008-09)-Financial assistance will be available to Indian students with at least 40% disabilities certified as per definition under Persons with Disabilities Act 1995.

• CENTRAL SECTOR SCHOLARSHIP SCHEME OFTOP CLASS EDUCATION FOR SC/ST STUDENTS- The Scheme aims at recognizing and promoting quality education among ststudents belonging to SC/ST, by providing full financial support. The scheme will cover SC/ST students for pursuing studies beyond 12th class

• RAJIV GANDHI NATIONAL FELLOWSHIP (RGNF) FOR SCHEDULED CASTE/SCHEDULED TRIBE CANDIDATES- to pursue higher studies such as regular and full time M.Phil. and Ph.D degrees in Sciences, Humanities, Social Sciences and Engineering & Technology.
